What are these two trends?


First, we will look at the roll-out of Central Bank Digital Currency (CBDCs).

Question #1: What Are Central Bank Digital Currencies? (CBDCs)



CBDC is generally defined as a digital liability of a central bank that is widely available to the general public. Today in the United States, Federal Reserve notes (i.e., physical currency) are the only type of central bank money available to the general public. Like existing forms of money, a CBDC would enable the general public to make digital payments.

Question #2: What was in Biden's March 2022 Executive order?



The Federal Reserve is sowing the seeds for its central bank digital currency (CBDC). It may seem that the purpose of a CBDC is to facilitate transactions and enhance economic activity, but CBDCs are mainly about more government control over individuals. If a CBDC were implemented, the central bank would have access to all transactions in addition to being capable of freezing accounts.

It may seem dystopian—something that only totalitarian governments would do—but there have been recent cases of asset freezing in Canada and Brazil. Moreover, a CBDC would give the government the power to determine how much a person can spend, establish expiration dates for deposits, and even

Biden signed an Executive order in March of 2022 directing the Central Bank to work on rolling out a Central Bank Digital Currency by Dec 13, 2022. It would not immediately replace the fiat dollar but will run in parallel to it until the dollar is later “retired” (or the whole Ponzi dollar system “collapses”). The development of central bank digital currencies (CBDCs) has accelerated in 2022 and is heading into 2023. Critics are worried, however, that the increasing adoption of CBDCs might trigger liberty and privacy concerns, as there's no limit to the extent of control the government could have over its citizens. Despite these concerns, central banks intend to digitize their currencies within the next decade.

The Federal Reserve Bank of New York recently [launched](#) a 12-week pilot program with nine major financial institutions, including Citigroup, Mastercard, and Wells Fargo, to experiment with a CBDC and a proof-of-concept digital money platform called the Regulated Liability Network.

G20 Promotes WHO-Standardized Global Vaccine Passport and 'Digital Health' Identity Scheme – The Epoch Times

Leaders of the Group of 20 (G20) have issued a joint declaration promoting a global standard on proof of vaccination for international travel and calling for the establishment of "global digital health networks" that build on existing digital COVID-19 vaccine passport schemes.

The joint statement followed the conclusion of the G20 summit held in Bali, Indonesia, where leaders discussed global challenges and coordinated policies in response, including to future pandemics.

"We acknowledge the importance of shared technical standards and verification methods, under the framework of the IHR (2005), to facilitate seamless international travel, interoperability, and recognizing digital solutions and non-digital solutions, including proof of vaccinations," the G20 joint declaration reads.

The leaders of the world's largest economies at the G20 meeting held in Bali, Indonesia, this week did much more than discuss current economic troubles.
